These meetings are always held in the central region of the state, which may call for travel, depending on what part of the state you reside. Time commitments vary based on the position; however, our Board of Directors is a cohesive team and Board members are required to assist to ensure the success of the ICCA Board of Directors and all ICCA events. Failure to attend meetings or participate on the Board may be cause for removal from the Board of Directors.
